District One (1) A total of 6.3 miles with one (1) strip in the middle. From State Highway 132 on Kiowa Road to 3/10 of a mile east on County Road 850.

A total of 20,634 feet of centerline yellow striping as follows; the mile with a curve is to have approximately 10,000 feet of double yellow striping; 2,656 feet of center line striping for the bridge replacement project near highway 132; and 7,978 feet of dash striping for the remaining route as detailed in the mapping.

Purpose of Form
