### Grant County Elevator Modernization Scope Work:

Elevator Modernization, adopted code ASME A17.1-2022 (except statewide variance on existing elevators for the hearing impaired) NEC 2020, IBC 2018

#### MACHINE ROOM

- 1. Provide convenient GFCI outlets only.
- 2. Machine room door must be fire rated for 1.5hrs min.
- 3. Machine room lighting must be a minimum of 19-foot candles.
- Confirm adequate room temperature/humidity as per elevator manufacture specifications.
- 5. All wiring in machine room must be in conduit or flame-retardant and jacketed.
- 6. Machine room must not be used as a chase way. Only elevator equipment and wiring allowed. Remove or separate plumbing piping.
- 7. Provide fused/breaker lockable 110v cab light disconnect.
- 8. Seal all penetrations for fire rating,
- 9. Existing breaker panel can remain, or be relocated.

#### **HOSITWAY**

- 1. Seal all penetrations in hoistway. Cover or remove wood from top of shaft and door frames.
- 2. Install door retainers on top of doors.
- 3. Remove all unrelated wiring in holstway.
- 4. All wiring in hoistway must be in conduit or of flame retardant type,

#### PIT

- 1. Provide guarded light with 10 foot-candles.
- 2. Provide sump pump or drain capacity to remove 3,000 GPH (verify)
- 3. Provide single GFCI or permanently wired for sump pump.
- 4. All Sump pumps must be provided with a full flow check valve and gate valve.
- 5. Provide convenient GFCI outlet.
- 6. Provide code compliant pit ladders. Ladder with be within a 39" horizontal plane from interlock.

#### **MISCELLANIOUS**

- 1. Provide re-opening device 3D detection of object in door path.
- 2. Install Phone failure device.
- 3. Install Emergency power illuminated signal, if equipped with stanby emergency power
- 4. All lobby landings must have 10fc of lighting.
- 5. Install Sprinklers in pit, machine room, or hoistway.
