The representative says that abrasion is what is causing the bottom of the galvanized tubes to rust out and although aluminized tubes are more expensive, they should last longer.

Fredrick reported D2 is moving excess dirt away from some of the recent bridge projects. D2 is also moving shale to build up some areas as needed. D2 plans to work on rock projects next week.

Stinson reported D3 will be hauling donated rock from the SandRidge oil pad near Jefferson. Rock hauling will start tomorrow to lay onto some of the neighboring roads. Apprentice will do a reboot of the system on Wednesday night. Key FOBs will be distributed to courthouse employees which will be for the interior doors on the north side of the courthouse. The north exterior doors to the atrium will be unlocked at all times.
