## MINUTES OF BOCC REGULAR MEETING

The Board of Commissioners of Grant County, Oklahoma (BOCC) held a regular meeting
Tuesday, February 20, 2024, at 9:00 am. Notice of the Meeting, including agenda, was posted at both entrances of the Grant County Courthouse, Medford, OK, Friday, February 16, 2024, by 9:00 am. in accordance with Title 25, §301-314 O.S.

Fredrick called the meeting to order at 9:00 a.m. After roll call, a quorum was acknowledged. Present were Craig A Fredrick, Max L Hess, and Steve Stinson. Cindy Pratt and Penny Huff were also present. Ben Bowers, Scott Sterling, and Jody Helm were present for portions of the meeting. Laurel Havens was in the meeting until 10:46 a.m. via audio conferencing.
Teleconferencing was enabled to comply with the Open Meetings Act. The commissioners used their signature stamp.

Stinson offered a prayer and Hess led the flag salute.
Pratt acknowledged the agenda was properly posted in compliance with the Open Meeting Act.
No comments from the public.

Hess seconded. Fredrick - aye; Hess - aye; Stinson - aye; Motion carried.

At 9:07 a.m. Stinson moved to skip to Item 6o. Hess seconded. Fredrick - aye; Hess - aye; Stinson - aye; Motion carried.

The floor was open to Laurel Havens, Administrator \& Executive Director of Muskogee Co EMS. Havens stated there is a cap on sales tax for ambulance services of 3 mills. Currently, Grant County ambulance services are funded through sales tax. Funding of a 522 Ambulance District would be through the ad valorum tax. This is determined by a vote of the people. Per HB1888 all counties within Oklahoma must have a plan in place for ambulance services, but this does not mean the County has to fund these services. Havens suggested the first thing the BOCC should do is request the call numbers and types of calls received in Grant County for ambulance services. This request would be sent to the OK State Health Dept in accordance with the Freedom of Information Act. This information needs to be reviewed for all ambulance services within Grant County. The Oklahoma Constitution determines how the board members are selected. A 522 Ambulance District would be annually audited by OSA\&I. All funding would go directly to the 522 Ambulance Board, which would be a minimum of five (5) members with expiring terms with one member being replaced annually. Each district within the county must be represented on this Board. Oklahoma State statutes are also followed which does not allow the board member to be paid to sit on this board. The board members are not allowed to be reimbursed for mileage for travel to and from board meetings. Stinson inquired about transferring ambulance equipment to 522 Ambulance Board and it was relayed that the 522 Ambulance Board can accept donations. Hess inquired as to whether the reports would show all volunteer and paid ambulance services within the county. Haven relayed that by OK State statute all ambulance services are required to submit specific information to the state. The open records request through the Freedom of Information Act should include (1) call received and the demographics of the call; (2) the severity of the call (patient compliant); (3) the location of the call (request actual location not by zip code); and (4) where the patient was transported to (to help determine the longevity of the call/run). It is estimated that the annual cost per ambulance unit is between $\$ 400,000$ and $\$ 500,00$. Haven relayed that approximately $80 \%$ of this cost is for payroll, benefits, etc. Haven reaffirmed the importance of concentrating on the fixed cost. The larger the area the more diluted the fixed cost become. The 522 Ambulance Board can contract with public service providers and/or private service providers.

At 10:46 a.m. Stinson moved to return to Item 6b. Hess seconded. Fredrick - aye; Hess - aye; Stinson - aye; Motion carried.

Discussion was had but no action was taken regarding the repairs needed at the jail building. Sheriff Sterling will get quotes on the work needed and check on relocating the inmates to
another county during the repairs due to the fumes produced from the products used for some of the repairs needed.
