MINUTES OF BOCC REGULAR MEETING

The Board of Commissioners of Grant County, Oklahoma (BOCC) held a regular meeting on **Monday, April 28, 2025,** at 9:00 am. Notice of the Meeting, including agenda, was posted at both entrances of the Grant County Courthouse, Medford, OK, Friday, April 11, 2025, prior to 9:00 am. in accordance with Title 25, §301-314 O.S.

Fredrick called the meeting to order at 9:00 a.m. After roll call, a quorum was acknowledged. Present were Craig Fredrick, Steve Stinson, and Keith McClure. Also present were Duane Thompson, Penny Huff and Rachelle D. McCaleb as Secretary. Lacy Reimer arrived at 9:21am. Teleconferencing was enabled to comply with the Open Meetings Act. McCaleb also discussed Oklahoma State Taxes reconciliation for 4th Quarter, 2024.
