Stinson reported D3 is mowing but has one mower in need of repair. D3 is hauling shale & rock and are working on pothole repairs. Stinson reported that Scott Falkenberg contacted him and will be off work until 08-19-22. Stinson plans to attend the CED#8 meeting on Wednesday.
