MINUTES OF BOCC REGULAR MEETING

The Board of Commissioners of Grant County, Oklahoma (BOCC) held a regular meeting **Monday, August 21, 2023,** at 9:00 am. Notice of the Meeting, including agenda, was posted at both entrances of the Grant County Courthouse, Medford, OK, Friday, August 18, 2023, by 9:00 am. in accordance with Title 25, §301-314 O.S.

Stinson called the meeting to order at 9:00 a.m. After roll call, a quorum was acknowledged. Present were Steve Stinson, Craig A Fredrick, and Max L Hess. Also present were Cindy Pratt, Cheyenne Gaff, and Penny Huff. Guest present: Jason Jump, John Merz, Maggie Jackson, and Louise Shaffer. Teleconferencing was enabled to comply with the Open Meetings Act.

Stinson offered the prayer and Fredrick led the flag salute.

Pratt acknowledged the agenda was properly posted in compliance with the Open Meeting Act.

No comments from the public.

No Transfer of Appropriation.

John Merz provided the revised plans for the GC Health Dept. Mr. Merz explained the original quotes received were over the budgeted amount for the project. Therefore, it is necessary to rebid the construction manager for this project. The main revisions to the plans are as follows: Change from metal frame to wood frame structure; exterior of south side of the structure will be metal panels rather than brick; revision from quartz countertops to less expensive countertops; removed one restroom; and removed the above ground storm shelter. Discussion was had to possibly use the \$30,000.00 ARPA funds allotted to the Health Department for the storm shelter construction. Mr. Merz will put the storm shelter as an alternate option on the revised specification for the rebid. Maggie Jackson stated she has applied for a grant to purchase the generator for the facility but if this grant is not approved then the ARPA funds allotted to the Health Dept would need to be used for the purchase of a generator. Merz will provide electronic copies of the revised plans to Clerk Pratt for placement on the County's website: www.grant.okcounties.org under the bid tab once the rebid has been approved. Stinson requested the rebid for a construction manager for this project be placed on the BOCC agenda for 08-28-23. All bid documents will be disbursed to the potential bidders by the Clerk's Office or obtained from the County's website, in order to remain in compliance with O.S. statutes.
