Board of Commissioners of Grant County, Oklahoma (BOCC) held a regular meeting **Monday**, **October 17, 2022**, at 9:00 a.m. Notice of the Meeting, including agenda, was posted at both entrances of the Grant County Courthouse, Medford, OK, Wednesday, October 14, 2022, by 9:00 a.m. in accordance with Title 25, §301-314 O.S.

Stinson called the meeting to order at 9:00 a.m. After roll call, a quorum was acknowledged. Present were Steve Stinson, Craig A. Fredrick, and Max L Hess. Also present were Buddy Carroll, Todd Hladek, Penny Huff, Kevin Kilian, Cindy Pratt, and Chuck Tolle. Teleconferencing was enabled to comply with the Open Meetings Act. Todd Hladek reported the Grant County Health Dept could use ARPA funds to assist with the construction of isolation rooms at the new facility currently in the process of being constructed and/or the purchase of a generator for the new facility. Hess relayed that the Health Dept has been saving for several years to construct a new facility. Due to the timing of the construction, costs are inflated, and the BOCC recognized the need.

Fredrick moved to approve \$30,000.00 of ARPA funds for the Grant Co Health Dept to use for the construction needs of the new facility. Hess seconded. Stinson – aye; Fredrick – aye; Hess – aye; Motion carried.

No action on gutters at the Courthouse (screens for caps and peeling of paint issues). Scott Falkenberg will get quotes for galvanized down spouts for the CH and present a quote to the BOCC once received.

Hess requested new business of consideration of a burn ban for Grant County. Hess and Fredrick have been in contact with several local fire departments within the county and they all agree that a burn ban should go into effect immediately.

Hess moved to approve resolution <u>2022-138</u> for a Grant County Burn Ban effective at 4:00 p.m. 10-17-22 and will expire at 11:50 p.m. Monday, October 24, 2022, unless extended by the BOCC. Fredrick seconded. Stinson – aye; Fredrick – aye; Hess – aye; Motion carried.

Hess reported the D1 foreman is still out on medical leave. D1 has completed the dirt project on Noble Rd west of CR 840.

Fredrick reported D2 is working half a mile south of CR 1050 on a shale project. D2 has mowers and graders running.

Stinson will attend the CDSA meeting on Tuesday and OPEH&W meeting on Thursday. Stinson has taken pictures of the CH lawn and proved to Plant's a Plenty who will make suggestions on proper vegetation to beautify the CH grounds. D3 has been placing shale on

school routes. The whole county needs moisture and Stinson hopes the public will be patient with the county until moisture is received and the districts can work the road more effectively.
