The Board of Commissioners of Grant County, Oklahoma (BOCC) held a regular meeting on **Wednesday, October 8, 2025,** at 9:00 am. Notice of the Meeting, including agenda, was posted at both entrances of the Grant County Courthouse, Medford, OK, Tuesday October 7, 2025, prior to 9:00 am. in accordance with Title 25, §301-314 O.S.

The County Clerk advised that the State Auditor's Office will be here on October 14th and 16th to review their FY 23-24 Audit Findings. She will meet with each officer individually beginning after the conclusion of the regularly scheduled BOCC meeting.

The County Treasurer indicated she attended the 522 Board meeting. She proposed to rescind the use of ARPA interest money (\$4,267.52) to renovate the Treasurer's vault, and instead to use this money for the 522 Board to retain Buddy Carroll (\$1500), obtain their cash bonds, and supplies.
