#### Dear Sirs:

Grant Road has a bridge on it that has been closed and impassable for many, many years. I would like to take the legal steps required to officially close this road and take it off of the State of Oklahoma's maintained rural roads. This letter to you and the other land owners is the first step of this process.

The second step will be to have a legal notice published in the Medford Patriot Star for three consecutive weeks to inform any and all interested parties of the hearing and closure.

The third step will be the hearing. This hearing will be held on August 8, 2022 starting at 9:30 a.m. at the Medford Courthouse during the regular scheduled Board of County Commissioners meeting. Once a decision is made about this road it will be final and all paperwork will be filed.

If this road is closed and any locked gates are placed to prohibit access all landowners abutting the old road will be given keys to make sure the gates can be opened as needed by landowners.
