

# RESOLUTION 2024-118

## NOTICE OF 522 AMBULANCE SERVICE DISTRICT ELECTION

### FOR GRANT COUNTY, OKLAHOMA

WHEREAS, on this 12<sup>th</sup> day of August 2024, at a regular scheduled meeting, the Board of County Commissioners of Grant County, Oklahoma introduced this resolution calling for an Election on the proposition set out herein below.

We, the majority of the Board of County Commissioners of Grant County, Oklahoma, hereby call an Election and give notice of such Election to be held in the County of Grant, Oklahoma on the 5<sup>th</sup> day of November 2024, for the purpose of submitting to the registered qualified voters of the below described school districts in said County for the following proposition:

#### PROPOSITION

Shall Resolution 2024-118 be approved, which proposes a 522 Ambulance Service District, composed of: Medford School-ISD 54; Pond Creek-Hunter School-ISD 90; Deer Creek-Lamont School-ISD 95; Timberlake School-ISD 93; Kremlin-Hillsdale School-ISD 18; and Billings School-ISD 2 located within Grant County, Oklahoma be formed for the purpose of providing ambulance services to all county residents residing in those school districts located within Grant County with an increase of a special annual recurring ad valorem tax for three (3) mills (which is 0.003) on the dollar of assessed valuation being levied in addition to all other levies, upon the taxable property in Medford School-ISD 54; PCH School-ISD 90; DCLA School-ISD 95; Timberlake School-ISD 93; Kremlin-Hillsdale School-ISD 18; and Billings School-ISD 2; located within Grant County of the Oklahoma Constitution, as amended, effective in the 2025 tax year, the proceeds of such levy to be used to provide funds to support, organize, operate, maintain and finance the Ambulance Service District and its purposed of providing ambulance services to residents of the Medford School-ISD 54; PCH School-ISD 90; DCLA School-ISD 95; Timberlake School-ISD 93; Kremlin-Hillsdale School-ISD 18; and Billings School-15D 2; within Grant County, Oklahoma?


